Her teams have won three Washington Catholic Athletic Conference championships and the girl's varsity program is consistently ranked locally, regionally and nationally. She was the Washington Post All-Met Coach of the Year in 1992-93 and was also a captain and starting member of the 1985 George Mason University National Championship women's soccer team. Coach Ashley has also spent 5 years as a coach with the VYSA Olympic Development Program and previously coached for 10 years with the Fairfax Police Youth Club and Springfield Youth Club in the U-9 through U-17 age groups.

Asst. Director: Joe Caputo

Joe Caputo has been the assistant varsity and junior varsity coach at PVI for 20 years. He spent 8 years as the head varsity girl's soccer coach at Fauquier High School in Fauquier County and 2 years at Garfield High School in Prince William County. He also has extensive experience as a WAGS youth travel coach in the U-14 through U-19 age groups.
